**Notice of intention to cite previous convictions  
under s.104 Magistrates' Courts Act 1980**

To A.B., of .....

You are hereby given notice that if, but only if, you are convicted of (any of) the offence(s) of ..... in respect of which you are summoned to appear before the ..... Magistrates' Court on the ..... day of ....., 19 ....., the under-mentioned convictions which are recorded against you will be brought to the notice of the Court; and if you are not present in person before the Court, the Court may take account of any such previous conviction as if you had appeared and admitted it.
