

REPRESENTATION OF THE PEOPLE, ENGLAND

The Greater London Authority (Relevant Registration Officers) Order 2007

Made - - - - 17th December 2007

Coming into force - - 14th January 2008

The Secretary of State makes the following Order in exercise of the powers conferred by section 44(3)(b) of the Electoral Administration Act 2006(a):

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Greater London Authority (Relevant Registration Officers) Order 2007 and comes into force on 14th January 2008.

(2) In this Order—

“Assembly constituency” means an electoral area specified by article 2(a) of, and the table in, the Greater London Authority (Assembly Constituencies and Returning Officers) Order 1999(b), as being an Assembly constituency for the purposes of Part 1 of the Greater London Authority Act 1999(c);

“Authority election” and “electoral area” have the same meaning as in section 203 of the Representation of the People Act 1983(d).

Assembly constituencies and relevant registration officers

2. For the purposes of section 42 of the Electoral Administration Act 2006(e), the registration officer appointed as relevant registration officer, for the purposes of all Authority elections taking place in each Assembly constituency listed in column 1 of the following table, is the registration officer for the borough listed opposite that Assembly constituency in column 2 of the table.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order appoints 14 local authority registration officers to act as relevant registration officers for the purposes of elections to the Greater London Assembly and the office of Mayor of London. In accordance with section 42 of the Electoral Administration Act 2006 (c.22), relevant registration officers are responsible for retaining and controlling access to election documents after a poll.

The registration officers designated by this Order are the same officers who are designated as constituency returning officers by the Greater London Authority (Assembly Constituencies and Returning Officers) Order 1999 (S.I.1999/3380).
