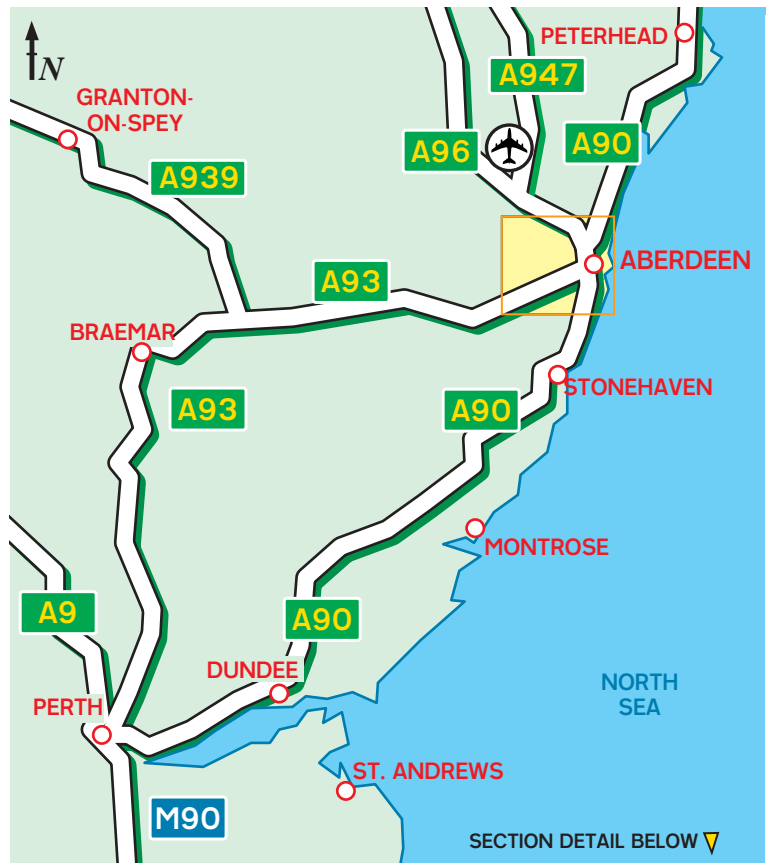

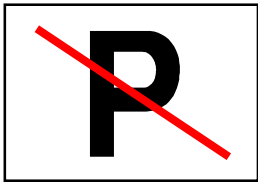

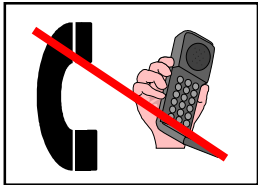

# Employment Tribunals Aberdeen



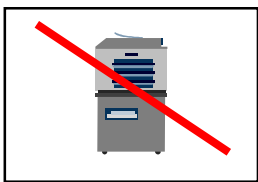
Car parking is not available at the Office. The nearest car parks are indicated on the map overleaf.
