
The Master of the Rolls as Head of Civil Justice approves the amendments to—

- c) 7.62, in the words in parenthesis at the end; and
- d) 8.1,

for “Practice Direction 8B” substitute “Practice Direction 49F”.

1) In paragraphs—

- a) 5.7;
- b) 7.44, in the words in parenthesis at the end; and
- c) 8.1,

for “Practice Direction 8B” substitute “Practice Direction 49F”.

THE PRE-ACTION PROTOCOL FOR PERSONAL INJURY CLAIMS BELOW THE SMALL CLAIMS LIMIT IN ROAD TRAFFIC ACCIDENTS

1) In—

- a) paragraph 12.10, in Table B (1); and
- b) paragraph 12.11, in Table C,

in the second column of both tables, omit the entry “**DO NOT** include details of any offers made by the **compensator** or the **claimant** that have not been accepted”.
